- Enable evidence-based policy-making, capacity building and tech assistance

2012-14: First regional (Asia-Pacific) surveys conducted



2017: 2<sup>nd</sup> global survey presented at the 6<sup>th</sup> Global AfT Review with new partners: ADB, Rep. of Korea



2019: 3<sup>rd</sup> global survey - Digital and Sustainable Trade Facilitation. New partnership with ICC



2025: 6<sup>th</sup> global survey addition two subgroups: TF for ecommerce and Green TF

2015: 1st global survey on trade facilitation implementation - presented at the 5th Global Review of Aid for Trade in partnership with UNCTAD, ITC, OECD, and subregional orgs. 2018: Launch of interactive website:

2021: 4th global





## Varying level of implementation across countries




## TF implementation in Mongolia (progress since 2015)

## **Key Trade Facilitation provisions in APoA**

#### **Simplification and Streamlining of Border Procedures**

"Encourage simplification and streamlining of documentation and border crossing procedures with the aim of substantially reducing port and border delays and costs."

#### **Development of Transport Corridors and Transit Facilitation**

"develop and strengthen transport corridors, including through streamlined border procedures, the implementation of legal frameworks and transit rule policies..."

#### **Legal and Institutional Frameworks for Trade Facilitation**

"improve their trade facilitation, including by harmonizing, simplifying and standardizing their transit rules, documentation requirements, border crossing processes and customs procedures, in line with existing international standards and best practices..."

# **Key Trade Facilitation provisions in APoA** (cont.)

#### **Digitalization of Trade and Customs Procedures**

"support the digitalization of trade and customs procedures to establish interconnectivity and ensure the fast and secure exchange of data and information concerning cargo and means of transport..."

## **Development of Transport Corridors and Transit Facilitation**





Significant variations within each regional group and among countries with special needs, particularly LDCs, LLDCs and SIDS







Fully supporting APoA on Digitalization of Trade and Customs Procedures+

# An enabling UN Treaty to accelerate trade digitalization

Open to all ESCAP member states to become parties

#### Objective

 To <u>facilitate</u> cross-border paperless trade by providing a dedicated intergovernmental framework to develop legal and technical solutions


#### A young UN treaty: growing fast

- But growing fast: from 5 parties in 2022 to 15 parties in 2025
- Mongolia joined in July 2022 and have actively participated in the discussions and implementation of the substantive provisions

#### **Key Provisions of the CPTA**

#### **Article 1: Objective**

The objective of the present Framework Agreement is **to promote cross-border paperless trade** by <u>enabling</u> the exchange and mutual recognition of trade-related data and documents in electronic form and facilitating interoperability among national and subregional single windows and/or other paperless trade systems, for the purpose of **making international trade transactions more efficient and transparent while improving regulatory compliance**.
